I, SmtDeepshikha Sherpa, Wifeof Sri Roshan Ghimiraypresently residing at C/o SriPhurba Sherpa, Mount View Apartment, Salbari, District-Darjeeling would like to inform you that I was married toone Sri Roshan Ghimiray, Son of Late Bhim Prasad Sharma, resident of Shiv Gram Lane No.1, Salbari, District-Darjeeling. Our marriage was solemnized on 28th November, 2021 as per the Hindu Rites and Rituals at Shiv Mandir, Mohorgaon Tea Estate and out of our lawful wedlock a daughter, namelyAmairawas born on 17thOctober, 2022. After my marriage my husband brought me to his abovementioned household and we started residing there along with his other family members, my mother in-law Smt. Shanta Devi Bhattarai and my Sister-in-law Smt.Roshna Sharma. After Marriage, 1 have noticed some abnormal attitude and behavior of my husband and other in laws members. My husband used to consume alcohol almost everyday and he is a habitual drunker and used to come home in the midnight or late hours. My in laws members know everything about the attitude, behavior and alcoholic habit of my husband but they never make any protest against such type of behavior of my husband and if I raised objection against such type of illegal acts and behavior, he did not bother to assault me physically and also abused me with filthy and abusive languages. Amairais 15 months old now. I have been mentally tortured by my husband and in-laws. My husband always insisted me to bring Dowry/ a good sum of money from my father as our marriage was the outcome of our love affairs and told me that if my father organized a social marriage ceremony, at least a good sum of money will be required and over this issue, he always created pressure upon me to bring the good amount from my father and when I refused to agree with his said proposal to bring the said amount from my father, he used to assault me mercilessly. In spite, of the aforesaid torture of my husband, I used to bear all such type of torture of my husband with a hope that in near future he will definitely realize his own mistake and thereby rectify himself but all my hopes have gone in vain. It is also pertinent to mention here that on several occasions my father has given him small sums of money in cash, which he said he has taken for his Business expansion and purchasing of land. It is pertinent to mention here that my

Husband is into Land Business and is a Land mafia have good connection with anti-social people. Furthermore, I was literally fearful after giving birth to a daughter because everyone was expecting a son. It was not even a week that I got discharged from the hospital that Roshan, his mother and sister talked about a second baby and that too a son. Roshan was forcing me a

lot for a second baby and he was specific that it has to be a son if not then we should try until we get one. He knew that I was not ready for this but they kept on insisting me or else I shall face dire consequences and isthe reason he wanted me out of his life. Subsequently, when I was just a week pregnant, he pushed me away while fighting with me, causing tremendous pain in my womb, almost causing a miscarriage. He used to come home drunk almost every night. He frequently came home late at night around 1am and at times 3-4am. He not only drinks alcohol but also smokes contraband items. Being his wife, I used to stop him and in return he used to fight with me saying that it's his life and I should not act as if I am his mother and these incidents of his torture and inhumanity became a normal daily affair, but I kept quiet thinking of our future and my pregnant situation and again another specific incident When my daughter was just 3 months old, He came home drunk late at night, fought with me and threatened me to leave the house along with my little daughter. That time my family had to intervene and he was demanding more money or else he will divorce me and they settled him down by paying him a sum of money at that very moment. His mother used to torture me in a way that it became unbearable for me and mentally I was loosing myself. I never got a place of being a wife and a daughter-in-law at that house, though I have fulfilled all of my duties in respective roles. His sister who is divorced twice had a lot of interference in my marriage life and provoked my Husband and Motherin-law to inflict physical and mental violence on me. Their insensitivity and hate towards the birth of my girl child can be well explained by the fact that my postpartum food and soup were prepared and delivered by my parents for exactly 21 days because my mother-in-law never cooked anything for me and my girl child. I would have died if my parents weren't there for me during that period. My mother used to come and give shower every alternate days to my new born daughter and massage her. My mother-in-law has no love and sympathy for her grand-daughter, she never showered her affection and care. My mother witnessed how we were being neglected along with the mistreatment she was getting from Roshan and his mother and out of nowhere her blood sugar level raised and reached to a point where the doctor suggested her insulin shots. She was serious and was admitted at Chennai hospital. I and my Daughter were not provided proper food by them for days as we were considered a burden to them and my father failed to provide/ fulfill their financial demands. Also, I am Roshan's second wife. His first marriage had also dissolved for the same reason of inflicting physical and mental torture by him and my in-laws . Furthermore , I would also like to state that I belong from a Schedule Tribe background and a Buddhist by religion and on several occasions when I performed my religious practices and rituals or prayers at my Matrimonial house, I have been shunned and humiliated and restricted from

doing so as my Husband and In-laws are Hindu by religion and Brahmins by caste, they would say that "my religious or Tribal Practices are not allowed in a Brahmin Household and these are low caste practices and should not be performed in a Brahmin household and specifically not infront of our Daughter as that would pollute her". They also at several occasions in the midst of our quarrel have insulted me and my parents in public that we are low caste tribal people and we should be fortunate that I am married to a Brahmin family and we should not forget our place/ status. And when I was thrown out of my matrimonial home, myself, my parents and my other relatives have gone to their home in protest of such acts and at that time also they insulted us and gave us caste slurs in public, saying us that I am not allowed at their place anymore.

That on 15th February, 2024 when my husband all of a sudden started a conflict with me after getting dead drunk and assaulted me and my daughter physically and he kicked me out of his house with my daughter and we were on streets that late night without letting me take any of me and my Daughter's belongings. Thankfully, my parent's house is nearby and we took a shelter there. All of the three people mentioned above disconnected my calls several times and later switched off their mobile phones, locked the house and ignored me and my small daughter and our desperate cry for help. Subsequently, the next day i.e. 16th of February, 2024 we come to know from a common acquaintance that He and my in-laws are trying to melt and sale my Stridhan Gold Jewelleries and cash out my Gold Jewelries and immediately the next day i.e. 17th February, 2024 I along with my parents and few of our relatives and Society members went to their Home to collect my belongings and my Gold Jewelries, but at first they were very rude and tried to physically assault us and completely denied of giving us the Gold Jewelleries but after being threatened of being called the Police, they allowed us to take and we could recover my Gold Jewelries and somehow managed to recover the same and amidst the fear of their wrongdoings to me and the Police being called they assured that my Husband is going come within few days to take me and my daughter back to my matrimonial home and resolve our differences amicably, but that thing never happened. In fact at present my Husband is threatening me and my family members with serious dire consequences if I don't give away my daughter to him also have tried a few times to by force enter my Parental house's Apartment complex compound and take away my daughter and on 27th February, 2024 he deceitfully tried to meet my daughter but subsequently, tried to forcefully take her away from me.

I, therefore, request you to investigate into the matter and please take appropriate strong legal actions against my husband and my mother in-law Smt. Shanta Devi Bhattarai and my Sister-in-law Smt. Roshna Sharmaas per the provision of law and obliged thereby.
