I undersigned would like to draw your kind attention towards the fact that one of my agent namely Amit Ghosh (Pan – AOYPG9822L / Aadhar number – 9002 8098 1907), son of Anil Kumar Ghosh, resident of Pabitra Para 25, Kotowali, Jalpaiguri, Pin Code: 735101 was inducted in the year 2020, month September, to facilitate sales and collect money from our esteemed customers. It is pertinent to mention here that we are into selling of cement and allied materials and for the same credits are given to our customers.

Our Office is situated at Homeland Building,4th floor,Sevoke Road,Salugara,Siliguri-734008. Said Amit Ghosh was assigned with the job of facilitating sales at Jalpaiguri and adjoining areas and collecting dues from my esteemed customers in lieu of ledger confirmations to be issued by him with the customers. He used to collect and deposit the amount at our office every Saturday. However he kept on misleading the customers as well as us by short/not depositing some amount on regular basis which thereby lead to accumulation of 14 lakhs.

In the first week of January, 2023, it came to our knowledge that said Amit Ghosh had forged the ledgers issued to our customers thereby collecting huge amounts from them and not disposing the same with our company. The accused person has manufactured fake ledgers and signatures of our esteemed customers. As of now the detected amount of money syphoned out by said Amit Ghosh amounts to Rs. 14 lacs (approx.) and the said amount could reach to 15 lacs or more after proper accounting is force.

On being asked about the same, accused person Amit Ghosh confessed his guilts and assured to return back the money. The accused person thereby manufactures fake ledgers and signatures of our esteemed customers, committed criminal breach of trust and thereby cheated us to the term of Rs 14 lacs (approx.) as disclosed. He also signed an agreement for the same (copy attached) to return the amount in installments. He therefore also provides us with 5 no.s of cheque that the amount shall be returned within 6 months.

We are anticipating that the accused person has misappropriated those collected money for his illegal gain. I am also anticipating that his family members and some other persons are involved in this crime as because, we have learnt that inappropriate bank transfers have taken place between him and his wife's account, name being Swapna Ghosh (Aadhar number – 4360 8085 9394)

I therefore request you to book the accused person and his associates under suitable provisions of law and thereby recover the misappropriate money.
