I, Smt. Babita Sarkar, W/O Bidhan Sarkar of Thiknikata, P.O-Sushruta nagar, P.S.-Matigara, Dist.-Darjeeling would like to inform you that the day before yesterday i.e. on 26.02.2024 at about 08:03 hrs, when my husband was entering to the alley towards his home from Asian Highway -II on his own Motor Cycle having registration no-WB74AJ-4881, at this time an unknown motorcycle which was going towards Noukaghat, Siliguri, in a rash and negligent manner suddenly hit his Motor Cycle near the Blue Bird Cafe, Thiknikata, P.O-Sushruta nagar, P.S.-Matigara, Dist.-Darjeeling as a result he fell down and got injuries on his head, the Unknown rider instead of helping him fled away from the spot towards medical more, thereafter the passerby peoples helped my husband and rushed him to the NBMC&H.
