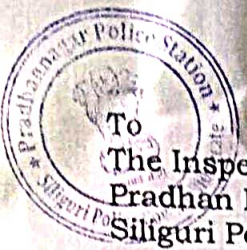

Subject: - F.I.R.

Sir,

In producing herewith one arrested accused person namely Thandar Gurung (35) S/O Lt. Dal Bahadur Gurung of Salbari Hat Bazar, PS- Pradhan Nagar, Dist. - Darjeeling under arrest along with following articles under proper seizure:-

(i) 22 (Twenty two) bottles of 70 UP INDIA MADE LIQUOR Himalayan Fata Fati containing 300 ml in each bottle i.e. total (22 x .300) = 6.6 ltrs which was kept in a nylon bag and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A-1".

I, SI Bandhan Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted accused person named Thandar Gurung (35) S/O Lt. Dal Bahadur Gurung of Salbari Hat Bazar, PS- Pradhan Nagar, Dist. - Darjeeling that on 01.03.2024 at 21.15 hrs I received a source information that one person storing and selling illicit liquor illegally at his residence cum hotel without any valid license. Accordingly, I share the information with you and noted in GD book vide Pradhan Nagar PS GDE No. 49 dated 01.03.2024.


As per your kind order and direction, I along with force left from PS to held raid at the house of above noted accused managed to apprehend him. On being asked he disclosed his identity as noted above and on search his residence cum hotel, I recovered above noted articles kept in a nylon bag. On demand he failed to produce any valid license/papers for selling and storing of such illegal liquor in his residence cum hotel. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and label the above mentioned illegal illicit distilled liquor from his procession in between 22.10 hrs to 22.55 hrs and subsequently, arrested the above mentioned detained person namely Thandar Gurung (35) S/O Lt. Dal Bahadur Gurung of Salbari Hat Bazar, PS- Pradhan Nagar, Dist. - Darjeeling after observing all sorts of formalities at the spot for violating the norms of Bengal Excise Act and inform him about the ground of his arrest.

Therefore, I pray before your good self that a specific case may kindly be initiated against accused namely Thandar Gurung (35) S/O Lt. Dal Bahadur Gurung of Salbari Hat Bazar, PS- Pradhan Nagar, Dist. - Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
