Sir,

With due respect, I am producing herewith 02 (two) arrested accused persons namely 1. Rakesh Ali (26), S/o- Mintu Mia of Pichla Pukur, PS- Kushmandi, Dist- Dakshin Dinajpur at present C/o- Md. Aslam of Pokaijot, PS- Pradhan Nagar, Dist- Darjeeling and 2. Tofajjal Hossain (29), S/o- Lt Asgar Ali of Tetul Pukur, PS- Kushmandi, Dist- Dakshin Dinajpur at present C/o- Md. Aslam of Pokaijot, PS- Pradhan Nagar, Dist- Darjeeling under arrest. The ground of arrest duly been communicated with them and the following articles under seizure :-

- (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 cm barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A".
- (ii) One live ammution (loaded) marked as Exhibit-"B".
- (iii) One white colour Bollero car displaying Registration No. WB 66 J/ 3514.

I, PSI Avijit Banik of Matigara PS, SPC do hereby lodge this written complaint against the above noted arrested accused persons. In this regard, I beg to report that today i.e. on 01.03.2024 during my special mobile van duty, at 15.45 hrs, I received a secret information that one vehicle having Registration No. WB 66 J/3514 with two persons was coming Siliguri from Malda with improvised fire arms and ammunition to deliver the same to their designated customer. Accordingly, I informed the matter to you and as per your direction, myself along with ASI Pema Dorjee Sherpa, C/523 Sanjit Kundu, C/868 Sujal Roy all of Matigara PS, SPC left for near to Siliguri Gate under Matigara PS with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Siliguri Gate at about 16.05 hrs and waited for the target. At about 16.40 hrs, as indicated by the source we were able to apprehend one vehicle as said above in which two persons are sitting inside the vehicle. On being asked they disclosed their identity as noted above. As per source information, that they were possessed improvised fire arms and ammunition. Hence, immediately I searched the above noted vehicle and found (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 cm barrel with one trigger, striking hammer, striking pin in working condition which is Marked as "Exhibit-"A" and (ii) One loaded live ammution which is marked as Exhibit-"B" from the said vehicle which were concealed under the driver's sit. They exclusively possessed improvised fire arms and live ammution illegally. On demand they failed to produce any document in support of the said improvised fire arms and live ammution which has been found from their possession. On further interrogation they stated that they are coming from Malda and will go to Siliguri to deliver the same to their designated customer for their wrongful gain. Thus when their involvement in carrying and possessing illegal fire arms and live ammution was established, I seized that improvised fire arms and 01 (One) round of live ammution which was loaded in the fire arms and the vehicle under proper seizure list duly signed by them as well as by available witnesses. The whole processes of search, seizure, label and arrest was made in between 16.45 hrs to 17.35 hrs on 01.03.2024. Accordingly, I, arrested the apprehended accused persons after issuing memo of arrest informing them about the ground of arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the accused persons namely 1. Rakesh Ali (26), S/o- Mintu Mia of Pichla Pukur, PS- Kushmandi, Dist- Dakshin Dinajpur at present C/o- Md. Aslam of Pokaijot, PS- Pradhan Nagar, Dist- Darjeeling and 2. Tofajjal Hossain (29), S/o- Lt. Asgar Ali of Tetul Pukur, PS- Kushmandi, Dist- Dakshin Dinajpur at present C/o- Md. Aslam of Pokaijot, PS- Pradhan Nagar, Dist- Darjeeling are desperate and dangerous in nature, as they was carrying the said fire arms for sell purpose.

As they have willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused persons namely 1. Rakesh Ali (26), S/o- Mintu Mia of Pichla Pukur, PS- Kushmandi, Dist- Dakshin Dinajpur at present C/o- Md. Aslam of Pokaijot, PS- Pradhan Nagar, Dist- Darjeeling and 2. Tofajjal Hossain (29), S/o- Lt. Asgar Ali of Tetul Pukur, PS- Kushmandi, Dist- Dakshin Dinajpur at present C/o- Md. Aslam of Pokaijot, PS- Pradhan Nagar, Dist- Darjeeling under appropriate section of law and arrange for its investigation.
