1. That UMESH BASFOR, son of Sri. Jiten Basfor is my legally married husband. A hindu marriage was solemnized between me and my husband on 26.12.1999 by following all the rituals of marriage. Since my marriage I have been residing with my husband at my above mentioned address. He is primary school teacher by occupation. Out of our wed lock one female child took birth namely Soniya Basfor (21 years).
2. That ever since my marriage, my husband use to torture me both physically and mentally. He is a drunkard and after drinking alcohol he always uses slang and abusive languages towards me in front of my said daughter. He often asks me to bring Rs. 2,00,000/- cash and golden ornaments from my father and when I deny to fulfill his demands he assaults me brutally on my persons and asks me to get out from his house.
3. That since our marriage my husband never fulfills our basic requirements. My parents incessantly requested my husband not to torture me and my daughter but in vain. I tried to change his nature and character with my love and care all these years but no fruitful result.
4. That on 01.03.2024 at about 11.00 P.M. when I was sleeping at our room of our above mentioned residential address my husband on a drunken condition entered our room and asked me to get out of our quarter after taking all my belongings and told me to return back only after bringing Rs. 2,00,000/- cash and golden ornaments from my father. When I denied to leave my house he became furious and started to assault me on my persons by fists, kicks and blows and with anything he found nearby and then pushed me out of the room by holding our neck. He threatened me that if I come again bare hands than they will kill me by setting fire on my persons after pouring keresone oil. At present I am at my paternal house.

I therefore request you to kindly take necessary legal steps against my aforesaid husband. I shall be highly obliged to you forever.
