Sir,

I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Goutam Sarkar (34yrs) S/O Lt. Gopal Sarkar of Halderpara, W.No. 41 PS- Bhaktinagar, Dist.- Jalpaiguri under arrest along with following seized articles;

1. Fifteen (15) sealed Bottles of Himalayan gold country spirit, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that today on 01.03.24 at 18-15 hrs Myself alongwith ASI Khagen Barman, C/1462 Sajan Miah, C/152 Abdul kayum Miah were performing Special evening Mobile duty vide NJP PS GDE No. 40 dt. 01.03.24. At 18-45 hrs received secrete source of Information that one person is selling Id Liquor illegally from Fulbari Line Hotel under NJP PS to its customers without any valid license. Accordingly I informed the matter to O.C. NJP PS and as per his instruction myself alongwith other officer and force left for Fulbari to verify the information. On arrival at the spot at 19-05 hrs It was found that one person mentioned above was selling liquor illegally from Fulbari Line Hotel to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is staff of the said Hotel and he is selling Id Liquor illegally from the said Hotel. Thereafter in presence of witnesses (1) Sumajit Kar (32) S/o Lt. Sanjoy Kar of Southcolony Bazar PS NJP Dist. Jalpaiguri and (2) Md Sahajan (38) s/o Md Uzir Ali of Fulbari PS NJP Dist. Jalpaiguri I recovered Fifteen (15) sealed Bottles of Himalayan gold country spirit, each bottle 600 ml from his possession and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the lliquor. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 19-05 hrs to 19-50 (seizure Total approx 9 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Goutam Sarkar (34yrs) S/O Lt. Gopal Sarkar of Halderpara, W.No. 41 PS- Bhaktinagar, Dist.- Jalpaiguri and arrange for Its investigation.
