Sri Titun Debnath all of them are resident of above noted address and I reside there last 32 years and I am the sole owner of the said land and the house. It is important to mention here that last few years I was subject to mentally and physically torture by my above noted sons and they always pressured me to transfer my aforesaid land and house in their names and when I protested the same at that time they all of them on **02/06/2023** assaulted me with help of some sharp cutting weapons with the inteion to kill me but at that time I did not lodged any complaint against them with a hope that one day they will changed their attitude in respect of me but such day never come into my life, ultimately 3 months ago when I was running my Pan shop namely Debnath Pan Vandar Situated at. Jalpimore at that time my sons came to my shop and started to asslated me and pressurized me to leave that pan shop and handover the same in their names, ultimately they thrown me out of my shop thereafter when I tried to entered at my house at that time also they very badly assaulted me with some sharp cutting weapons with the intention to kill me and thereafter they all of them after making conspiracy when I was sleeping at my room at that time they all of them with the help of pillow tried to stop my breath and intionally tried to kill me so, no other alternative way or with the marcy of god I took shelter at the house of realtives house and after the said incident till now I always tried to enter my house but I failed and right now they all of them threatened me continuously so, I spend my days with in fear and being an aged person I am unable to give them any lessons so, no other alternative way I lodged this complaint aganst them.

Therefore I request you please take necessary legal actions against the above named persons as early as possible.
