Subject : Complaint about house trespass, criminal intimidation, theft, sexual harassment, attempt to cause severe hurt, attempt to murder and causing mental harassment by my neighbor Mrs. Ruby Das and her husband Mr. Chandan Das.

Sir/Madam,

This is Anuradha Pandey, daughter of Hansa Pandey, writing on my mother's, that is, Hansa Pandey's behalf to you about a heinous act that was committed by my neighbor, Mrs. Ruby Das and her husband, Mr. Chandan Das on 03/03/2024, that is, 3rd of March 2024. Mrs. Ruby Das and Mr. Chandan Das are my neighbours and they live just next to my home. They both live in kathal-tala more, behind Amra Bengali party office, Netaji Subhash Road, Bhaktinagar, NJP, Siliguri, 734007, West Bengal. The incident took place at my residence, which is, at Upendra Bhawan C/O Hansa Pandey, Kathal-tala more, Netaji Subhash Road, Bhaktinagar, NJP, Siliguri, 734007, West Bengal.

The act was committed in the evening when I was out in the market for getting groceries. My mother, Hansa Pandey is a widow who's struggling with disease cancer. She lives at home all day and night, alone. I go to work and return late at night. Taking advantage of my mother's aloneness and vulnerability, Mrs. Ruby Das and her husband, Mr. Chandan Das came to my home's entrance gate that remains closed everytime, and broke open the metal gate by using criminal force and then trespassed my home. They both entered my home campus and used criminal force on my mother, Hansa Pandey. Then Mrs. Ruby Das snatched my mother's hair by force, thrashed her, assaulted and pulled away the gold chain that my mother wore
