While patrolling the line, the maintenance team has noticed that some parts of the transformer structure at Kestopur Bazaar are missing.

For the transformer structure at Kestopur Bazaar, the missing items are as follows:

For stable operation of transformers these parts are essential. Therefore, I would request you to investigate the matter as some unknown miscreant might have stolen these parts from existing structures and treat this as F.I.R. under S/C 136/1(a) of The Indian Electricity Act.
