With due respect, I, the undersigned, state before you that **Sahani**, son of Hiralal Sahani of ward no. 35, Ram Nagar Colony, Bhaktinagar, Jalpaiguri, at around 9 am on 05/03/2024, enticed and took away my wife Kaushalya Kumari Roy (24 years) along with my 2.5 years old son Ayansh Roy, from my present address at Santoshi Nagar, ward no. 5, Siliguri. Raju Sahani had an evil eye on my wife and trying desperately to get her away from me since last few months. He was trying to force my wife to establish illicit relationship with him.

My wife Kaushalya Kumari took away my ATM and a sum of rupees 70,000/- (Rupees Seventy Thousand) and all the documents of my son Ayansh Roy.

I apprehend that my wife and son may get trafficked by Raju Sahani. My wife and son are under imminent threat of life and limb.

Kindly help me find my wife and son as soon as possible.

I shall remain indebted to you.
