Sir,

I, RINKI BARMAN, son of Sri. Dilip Barman, permanent resident of Vill. Kawakhali, Netaji Para, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that as follows:-

1. That (i) NILIMA ROY, wife of "not known" his son (ii) RAM ROY, son of Nilima Roy and (iii) NISHU ROY wife of Ram Roy are my neighbours.
2. That on 01.03.2024 at about 4.00 P.M. when my aforesaid daughter and my minor son namely SHIVAM BARMAN and Lovely Roy daughter of Unknown, (aged about 13 years) who is the niece of said RAM ROY was playing in the field beside my house. But at 4.30 P.M. my daughter and said Lovely Roy started fighting for some silly reason said RAM ROY and NILIMA ROY came running into the spot and started to brutally assault my minor daughter and son on their persons and also uttered filthy language upon my daughter by saying "MAGHI" and also pelted stones upon my children and my four goats. At about 5.00 P.M. when I returned from the anchal office I found my children were lying on the field and crying loudly. They received severe injuries on their persons. On learning about the incident from my daughter I went to their house for lodging complain but said RAM ROY and his mother NILIMA ROY became furious and assaulted me with bamboo and also uttered slang, filthy and offensive languages upon me. Said RAM ROY also tore my clothes. The local people rescued me from their hand. Due to the physical I had received severe injuries on my persons.
3. That on 05.03.2024 at about 10.00 P.M. said RAM ROY, NILIMA ROY, and NISHU ROY entered my house forcefully and threatened me and my husband that if I lodge a complaint against them to the police about the above incident than I and my daughter will have to face serious consequences.

I therefore, request you to kindly take necessary legal steps against the aforesaid three culprits. I shall be ever obliged to you.
