So sir, on 07/03/2024 the exact evening time is 17:09 hrs, tried to withdraw money from SBI ATM No.T1NF004789178, under bridge at shivmandhir , then a tall man with a beard came in there and looked very smart, when I tried to withdraw money he was behind me, when the money didn't come he took out my ATM card and another man was short by his side and together they changed my ATM, they left, then I came home and then I got a message on my husband's mobile that Appx Rs.71,000/- (Rupees seventy one thousand only) was withdrawn, so I told my husband what had happened then he blocked my ATM.

3. This theft is within your jurisdiction, I request through this first notice to find out the culprit and refund my money at the earliest please, I have attached all the related files with this report. I will never forget this help.


