Sir,

In producing herewith following seized articles under proper seizure list viz. (i) Twelve (12) bottles of Himalayan Gold 60° UP Indian Made Liquor, each containing 600 ml @ Rs. 155/- and (ii) Five (05) bottles of OYE OYE 70° UP C.S., each containing 300 ml @ Rs. 28/- (total 8.7 ltrs & total value Rs. 2000/-), I, SI Debabrata Kundu of Bagdogra PS, Siliguri Police Commissionerate, Dist- Darjeeling, do hereby lodge this written complaint against one Smt. Lakhi Rai (F/58 years), w/o- Late Kumar Rai, r/o- 35, Panighata Road, near Kedarnath School, Upper Bagdogra, Gadadhar Pally, PS- Bagdogra, Dist- Darjeeling to the effect that on 07/03/2024 at 23:15 hrs I received secret source information that a huge quantity of liquor is stored at the shop cum house of one Smt. Lakhi Rai at Gadadhar Pally, Panighata Road, near Kedarnath school and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and diarised the matter in GD vide Bagdogra PS GDE No. 413 dated 07/03/2024. Accordingly, I along with ASI Munna Ahmed, VP/02 Prodip Roy left for Gadadhar Pally, Panighata Road, near Kedarnath School to work out the secret source information. At around 23:30 hrs we reached at Gadadhar Pally, Panighata Road, near Kedarnath School and being indicated by source we held a raid to verify the veracity of information. Seeing the police personnel the owner along with some customers managed to flee away from the spot. On enquiry it could be learnt that one Smt. Lakhi Rai (F/58 years), w/o- Late Kumar Rai, r/o- 35, Panighata Road, near Kedarnath School, Upper Bagdogra, Gadadhar Pally, PS- Bagdogra, Dist- Darjeeling is the owner of said shop cum house. Then we searched and on search, we managed to recover the above noted liquor from the shop cum house of said Smt. Lakhi Rai. On demand, none came forward to produce any valid document/license for possessing, stocking and selling those liquor and country spirit. It could also be learnt that said accused Smt. Lakhi Rai has been possessing, stocking and selling liquor & country spirit from her shop cum house for a long time for her wrongful gain. Due to odd hours of night no independent witness could be available there. Accordingly, I seized that liquor under proper seizure list. The process of search and seizure was made in between 23:35 hrs and 00:10 hrs.

Therefore, I request that a specific case under proper section of law may kindly be started against the involved absconding accused person Smt. Lakhi Rai (F/58 years), w/o- Late Kumar Rai, r/o- 35, Panighata Road, near Kedarnath School, Upper Bagdogra, Gadadhar Pally, PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
