I, Mithun Haldar son of Late Jayanta Haldar, resident of Baikunthapally, Ward No. 41, Near Satvika Academy, P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri, Pin 734001 am the father of Master Aditya Haldar aged about 13 years and I would like bring to your notice that today i.e. on 07.03.2024 at around 4.00 pm I was informed by my cousin brother that my son Master Aditya Haldar has met with an accident. He was hit from the back by a Pickup Van having registration no. WB73D7396 between 3.30 pm to 4.00 p.m. while he was going to tuition from my residence and was walking towards palden more from our residence. This incident happened when the said vehicle was moving towards back and my son was walking at the side of the road, and the vehicle hit its backside at the back of my son and was run over his left leg and he was severely injured. Upon information when I reached the place of occurrence my son was injured severely and I instantly took him to the Anandaloke Multispecialty Hospital and he is still under treatment and observation of various doctors. I also want to bring your notice that my son have several fractures in his left leg.

The vehicle bearing No WB73D7396 which was loaded with Tea was detained and handed over to police by the local people and now I want to make a complaint for rash, and negligent driving against the said driver of the vehicle no. WB 73 D 7396.

Under the above circumstances I would request you to investigate the matter and take appropriate legal action in this regard and for this act of kindness I am highly oblige to you forever.
