I am Pinki Routh, D/O-Sandeep Routh, I would like to inform you that on the morning of March 7, 2024, at around 9:30, I was waiting for an auto rickshaw at Milan More to go to Vidhan Market to purchase goods. At that moment, we stopped taxi number WB 73 E 8152 and negotiated a fare of Rs.200 with the driver to drop us at Vidhan Market. As soon as I boarded the taxi, the driver started talking, mentioning that your husband Pawan is his friend and asking why he hasn't been given a divorce yet. When we opposed this, the taxi driver began misbehaving, threatening us with physical harm if we revealed anything. He forcefully took Rs.10,000 from my purse and a gold chain from my neck. My friend and I managed to escape from the car near Milan More, running back home in fear.

I am currently going through a divorce case with my husband, which is pending in court. I am deeply disturbed by this incident. Our friend, Raksha Gurung, was present with us during the incident.

I request that an FIR be filed against the taxi driver in this matter.
