Sir,

In producing herewith (04) four arrested accused persons namely (i) Shibu Pal (24) S/O Lt. Buddhadeb Pal of South Ambedkar Colony, W/No. 01, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Raja Sarkar (23) S/O Nikhil Sarkar of Baghajatin Colony, near Mukta Manch math, PS-Pradhan Nagar, Dist.- Darjeeling (iii) Umesh Yadav (20) S/O Rajballi Yadav of Prakash Nagar, behind Hanuman Mandir, W/No. 43, PS. Bhaktinagar, Dist. Jalpaiguri, (iv) Bappa Saha (32) S/O Lt. Biswa Saha of Gurung Busty, near Ram Narayan Math, W/No. 03, PS. Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure :-

- (1) One iron made weapon locally called as "Bhojali" measuring 22 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Shibu Pal.
- (2) One iron made sharp cutting weapon locally called as "Da" measuring approx 20 inch in length including wooden butt recovered and seized from the possession of accused Raja Sarkar.
- (3) One iron made sharp cutting weapon locally called as "Kukri" measuring 18 inches in length and one torch light recovered and seized from the possession of accused Umesh Yadav.
- (4) One iron made breaking instrument locally called as "Sarashi" measuring 18 inches in length and one torch light recovered and seized from the possession of accused Bappa Saha.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 04 (four) arrested accused persons and their 04/05 unknown associates who involve in this crime to the effect that on 08.03.2024 night at 23.30 hrs received a specific source information that about 08/09 persons assembled at below Mahananda river Bed, Cooliepara under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoity at Gurung Busty area.

Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 467 dated 08.03.2024. After getting the permission from the I/C, Pradhan Nagar PS myself along with ASI Amar Raj Subba, ASI Monaj Kr Roy, ASI Biplab Kr. Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar, C/1415 Chandan Basak and C/1416 Dilip Barman all of Pradhan Nagar PS left for Coolipara under Pradhan Nagar PS to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of climax of the situation and not to afford them opportunity for the concealment of evidence or facility for their escape. On the way, I informed the matter to RT van officer ASI Mirza Hossain of Pradhan Nagar PS and directed him to come at Coolipara near Mahanda Bridge to accompany with us for holding raid at below Mahananda bridge, Coolipara. At about 23.55 hrs we reached at Coolipara near Mahananda Bridge and after few time, ASI Mirza Hossain along with his force arrived at Coolipara, near Mahananda Bridge and accompanied us. Thereafter, I contacted with my source and as pointed by the source we noticed that 08/09 persons assembled at below Mahananda Bridge and they were whispering in a very low voice. We cordoned the place with due care and caution.

On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted four (04) accused persons with deadly weapons in their possessions while 04/05 others managed to flee away from the spot taking the opportunity of darkness by crossing river Mahananda. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Gurung Busty area. Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 00.50 hrs to 01.55 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the four (04) arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Gurung Busty area.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted 04 accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Gurung Busty.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted four (04) arrested accused persons namely (i) Shibu Pal (24) S/O Lt. Buddhadeb Pal of South Ambedkar Colony, W/No. 01, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Raja Sarkar (23) S/O Nikhil Sarkar of Baghajatin Colony, near Mukta Manch math, PS-Pradhan Nagar, Dist.- Darjeeling (iii) Umesh Yadav (20) S/O Rajballi Yadav of Prakash Nagar, behind Hanuman Mandir, W/No. 43, PS. Bhaktinagar, Dist. Jalpaiguri, (iv) Bappa Saha (32) S/O Lt. Biswa Saha of Gurung Busty, near Ram Narayan Math, W/No. 03, PS. Pradhan Nagar, Dist. Darjeeling and others 04/05 unknown miscreants and arrange for its investigation.
