In producing herewith one lady accused person namely Mohini Devi Paswan (40) W/O Suman Paswan of Swami Nagar Colony, W/No. 07, Khalpara, P.S- Siliguri, Dist.- Darjeeling after maintaining her decency along with following articles under proper seizure list-

1] 15 (Fifteen) bottles of 70 U.P OYE OYE country Spirit Country Spirit (each bottle containing 300 ml, Total 4.5 Liters, Total Value Rs. 600/-)

I, ASI Samiran Das of Khalpara T.O.P under Siliguri Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Mohini Devi Paswan (40) W/O Suman Paswan of Swami Nagar Colony, W/No. 07, Khalpara, P.S- Siliguri, Dist.- Darjeeling to the effect that today on 10/03/2024 at 08.55 hrs. while performing morning van duty, received a source information that one lady is selling liquor in a house situated at Swami Nagar Colony, W/No. 07, Khalpara, P.S- Siliguri, Dist.- Darjeeling without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with L/C 1216 Pushpanjali Yonzon, C/390 Sujit Paul, CV/999 Amar Mandal had been to Swami Nagar Colony under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no. 244 dated-10.03.2024. On reaching there and as identified by the source it found that one lady was selling and storing liquor in a house at Swami Nagar Colony, W/No. 07, Khalpara. Subsequently, I along with officer and force cordoned house and was able to detain the above noted person. Subsequently on being asked the apprehended lady accused disclosed her name and identity as noted above. Further being searched the above noted articles were found in her house. On demand she failed to produce any valid license/papers for selling and storing of such articles. On further she stated that she is involved in selling and possessing of liquor without any valid license for last 03 (Three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 09.45 hrs to 10.15 hrs at the spot. As she has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended lady accused person namely Mohini Devi Paswan (40) W/O Suman Paswan of Swami Nagar Colony, W/No. 07, Khalpara, P.S- Siliguri, Dist.- Darjeeling after observing all sorts of formalities u/s 41 Cr.P.C appraising her the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Mohini Devi Paswan (40) W/O Suman Paswan of Swami Nagar Colony, W/No. 07, Khalpara, P.S- Siliguri, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
