Sir,

I, SHACHI SHARMA, Wife of Abhishek Sharma, resident of Prakash nagar, Near Kamla Medical Hall, 2.5 Check Post, Sevoke Road, Siliguri-734 008, P.S. Bhaktinagar, beg to inform as under for taking necessary action:

MRS. KOMAL CHUGH (daughter of Smt. Dimple Chugh) wife of SHRI DINESH KUMAR AGARWAL, resident of Dolphin Signature, Jyoti Nagar, Near Terai Blood Bank, Siliguri-734001, under Bhaktinagar P.S. entered into an agreement with me and my husband ABHISHEK SHARMA on 17.12.2021 for sale of her owned and possessed office room being office No. "515" about 823 sq. ft. including super-built area on 2nd floor (backside) of the building designated as "THE PLANET" situated at Planet Mall, 2nd Floor, Sevoke Road, Siliguri, under your jurisdiction. After inducement of Smt. Komal Chugh and her husband Shri Dinesh Kumar Agarwal, on their inducement the matter of sale was finally decided for the sum of Rs. 68,50,000.00 cost of premises plus the sum of Rs. 30,00,000.00 cost of interior works. Thus, total cost price was fixed at Rs. 98,50,000.00. Out of said sale price we, paid the sum of Rs.15,00,000.00 (Rs.1,00,000.00 in cash and Rs. 14,00,000.00 through RTGS of Axis Bank and HDFC Bank) on several dates to Mrs. Komal Chugh and her husband Dinesh Kumar Agarwal. The sum of about Rs. 10,00,000.00 paid to several contractors on several dates as per the instruction of Komal Chugh and Dinesh Kumar Agarwal for fixing interior works and the sum of Rs. 2,00,000.00 approx was spent as processing charges & loan interest on obtaining loan from the IDBI Bank towards the payment of consideration for the said premises. Despite repeated requests and demands from us, Smt. Komal Chugh and her husband Shri Dinesh Kumar Agarwal could not do the needful to registered the aforesaid shop in our name. Further Smt. Komal Chugh and her husband Shri Dinesh Kumar Agarwal were negotiating the said premises with other purchasers also for some higher price and started delaying registry of the premises. After delaying for 2 months and out of frustration we have to cancel the loan and so the balance amount could not be paid.

Upon the inducement of the aforesaid Mrs. Komal Chugh and her husband Shri. Dinesh Kumar Agarwal we paid the said amount and now that we have requested them, several times, to refund the said amount as they are not willing to sell the said property, they are clearly refusing to do so and are in turn threatening us with dire consequences. They have cheated us by taking money for the interior designing as well but they have not designed/constructed in the interior of the said premise as per my requirements for the said premises. That their motive was clear

that they wanted to cheat us from the very beginning by inducing us to purchase the aforesaid premise and made us to pay a sum of Rs. 25,00,000/- (Rupees Twenty Five Lakhs only) and upon their instruction and assurance we spent about Rs. 2,00,000/- (Rupees Two Lakhs only) for obtaining loan from a financial institution. They are now threatening us that if we ask them to refund the money they will harm us and that we should forget about the said money. Today i.e. 09.03.2024 at around 08:00 am we visited the aforesaid person and requested them to return the said amount but they in turn started quarrelling with me and started assaulting me. They clearly refused to return back the said amount and in turn threatened us that if we made any attempts to contact them they shall came to our house and harm me and my family.

You are requested to kindly to look into the matter and do the needful to start a specific case against the aforesaid Shri Dinesh Kurmar Agarwal and his wife Smt. Komal Chugh under the provisions of law.
