I "Albina Kujur" sister of the victim "Salmi Kerpelta" who is the
wife of "Birender Kerpelta" the culprit begs to inform you that my sister
is married to Birender Kerpelta for 22 years and has 2 children aged 2 years
and 16 years respectively and are the residents of "Jayantika Tea Estate Factory line,
Purbamadall, Kamala Sahabad, Dajuly."
They were having quarrels regarding domestic issues since after their marriage
and it was escalating as day progressed. Today at around 12:15pm my sister
who was working as a househelp in a house situated in "Bhalajally" area of Siliguri,
"Birender Kerpelta" went to visit her, at that time the house owner was not present
in the house but his wife and mother present in their respective rooms.
While opening the door my sister was brutally attacked by "Birender Kerpelta"
with a large knife (খোখনি) multiple time which made her bleed profusely and
she fell on to the floor and in the mean time "Birender Kerpelta" the culprit
escaped and tried to flee from the spot but caught and handed over to
the police with all the evidences and my sister "Salmi Kerpelta" the victim
was rushed to the hospital then and there after the incident by the
house owner and she is in a very critical condition and is in life danger.

So, you are kindly requested to take all the necessary and legal steps against
the culprit "Birender Kerpelta" who happens to be my sister's husband and I'll
be highly obliged.
