I Smt. Shyamoli Chandra wife of Sri Kanu Chandra

Resident of P.C. Sarani Deshbandhu para Siliguri
would like to inform you that on 11.03.2024
my neighbour Sri Prasanta Das who resides in the same
building have launched an attack on me for a petty reason
as he resides in the same where he has shifted recently
As our electric meters are still common as I still
haven't got his individual connection yet. As the Eddy
meter is common so it was already discussed before as that
by the time he gets his separate connection our bills
will be split. When my husband Sri Kanu Chandra
asked him about the bill Mr Prasanta Das without any
reason has attacked him along with his family members
including his wife and son. They forcefully entered
our grocery shop which is located in the same premise
and started beating my husband. I tried to intervene as
I feared he would not hit a woman but to my
utter surprise he has hit me on my face and also
threatened to kill me and used blunt iron war by
to me

I therefore request you to kindly look into
the matter and do the needful as I am feeling unsafe
in my own building
