In producing here with the one arrested accused person named Suresh Singh (44 years) S/O Mani Kumar Singh of Jyotinagar near Vidyasagar Club, ITT road ward no 41 PS Bhaktinagar Dist Jalpaiguri, along with following seized articles as per proper seizure list:-

I, SI Basudeb Guha S/O Lt Badal Ch Guha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that on 12.03.2024 at about 15.05hrs I received source information that Mani consultancy services is running illegal motor vehicle registration business which is located Jyotinagar near Vidyasagar Club, ITI road ward no 41 PS Bhaktinagar Dist Jalpaiguri. Accordingly I, informed the matter to you and noted in GDE for reference vide Bhaktinagar PS GDE No. 548/24 dated 12.03.2024 as per kind order of I/C Bhaktinagar PS I along with SI Youel lepcha, ASI Dipak Karmakar,C/828 Dulal Ch Barman, C/ 1434 Ananta Ram Bara all of Bhaktinagar PS left to work out the information.

At around 15.35hrs I reached at Jyotinagar near Vidyasagar Club, ITI road ward no 41 PS Bhaktinagar Dist Jalpaiguri and as shown by the source we entered into the Mani Consultancy and found one person there and when we expressed our identity to him, he tried to flee away though after short chase we able to intercept him. On asking he expressed his identity as Suresh Singh (44 years) S/O Mani Kumar Singh of Jyotinagar near Vidyasagar Club, ITI road ward no 41 PS Bhaktinagar Dist Jalpaiguri. We informed him that he may search us before we search the premises of Mani Consultance but he refuses to do so. Then we search the premises in presence of him and local witnesses and found above noted seized article. On being asked he could not produce any supporting documents regarding the recovered articles. Then I seized above noted number plates of vehicles recovered from his office drawer under proper seizure list When I went to serve notice U/S 41A Cr.P.C to him he again tried to fell away to evade Ld Court procedure. Finding no other alternative, I arrested him under proper memo of arrest after observing all the formalities of arrest. On interrogation he confessed that he along with his associates were involved in transferring number plates and issuing false R.C book of stolen or otherwise procured vehicles and sell those vehicles to used car sellers for wrongful gain.

AS the accused and his associates made, possessed false and forged number plates of vehicles to be used as genuine with intend to commit fraud and cheating to used vehicle purchaser.

I, therefore pray before your kind honour that a specific case may kindly be registered against the Suresh Singh (44 years) S/O Mani Kumar Singh of Jyotinagar near Vidyasagar Club, ITI road ward no 41 PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
