Sir,

I, Ranadip Mazumder, S/O :-Late Kalipada Mazumder , AE & Station Manager, Powerhouse CCC , WBSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 12.03.2024 at Shastri Nagar(Near Hansh Bala Ashram), which I believe warrants immediate attention and investigation. The incident involved an accident by Concrete Mixer Truck (Bearing no:- WB73/G5460 & Mob No:- 9051551551/6205804109) with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSEDCL's property and public safety.

As information received from the accident location at 2.20 PM, Our technical team attend the spot immediately at 2.30 PM and found that 02(two) nos 8 Mtr PCC pole broken with damage of other electrical installation due to the accident with Mixer Truck. Rectification work commenced from 3.00 PM for restoration of power at those localities and completed on 6.30 PM.

The total financial losses caused due to this accident are approximately Rs. 55000.00 (Fifty Five Thousand) only.

Given the potential risks and significant financial implications, I kindly request you that a FIR be registered regarding this accident against the Mixer Truck No:- WB 73/G5460. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSEDCL property.

This is for your kind information and further needful action please as per law.
