Gauri Paul, Wife of Late Prakash Chandra Paul, brother-in-law, Shirshendu Paul, Son of Late Prakash Chandra Paul and one unknown person to the effects that on 12-03-2024 at about 10:00 A.M., the above-named persons forcefully entered into and/or at the back side of my house room on the ground floor and started abusing me in most indecent and filthy languages and threatened me to withdraw all criminal cases and Domestic violence case against them pending in Siliguri Court and when I denied to do the same, my brother-in-law with the incitement and instigation of my mother-in-law suddenly hold me tightly and tried to molest me with an intention to outrage my modest and when I resisted him, he along with my mother-in-law assaulted me physically and throttled me by my neck with an intention to kill me.

So, therefore, I humbly request you to take stringent legal action against my in-laws above-named person and unknown person and booked them under the provision of law applicable at an earliest.
