Dear Sir,

1. This complaint is being filed on behalf of M/s Pidilite Industries Limited ("Complainant Company"). The Complainant Puneet Dhingra is the authorized representative of the Complainant Company by way of the attached Letter of Authority issued in favour of Semita Legal.
2. The Complainant Company is an industry leader in manufacturing of goods including Fevikwik, Mseal, Fevicol, Araldite, Dr. Fixit etc. The Complainant Company and its licensees exercise strict quality control over the production of its products including the use of the intellectual property in the writing manner of the brand names Fevikwik, Mseal, Fevicol, Araldite, Dr. Fixit etc.
3. It has recently come to the knowledge of the Complainant Company that certain people/entities falling within your jurisdiction are engaged in illegal, unauthorized and unlawful sale and trading of identical and deceptively similar products of the Complainant Company along with substantial and identical reproduction of the artistic work of the company's product packaging, thereby amounting to infringement of the copyright vested in the Complainant Company's artistic work under the Copyright Act, 1957.
4. In light of the above stated facts, you are requested that the information contained herein be reduced to a First Information Report (FIR) under Section 420 of the Indian Penal Code, 1860 and Sections 63, 65 of the Copyright Act, 1957. You are also requested to investigate into the matter including arrest of the known/ un-known accused persons and seizure of equipment being used to manufacture the counterfeit products which amounts to infringement of copyright.
