I would beg to inform you that I am an unmarried girl living with my old aged mother in her house at salugara near old Radio Center in ward no.42 of S.M.C, Bhawsindh Colony, P.O. Sevoke Road, Under Police Station: Bhaktinagar District - Jalpaiguri, In our house my elder sister namely Smt. Pushpa Das and her daughter namely Pooja Das also living.

That on 05/02/2024, my father Sitaram Maurya died and after his death I became complete the funeral and Sradha Ceremony of my father as because we have no any brother.

That after the death of my father, my brother-in-law namely Md. Mantu Ali who is residing at the Back side of old Radio Center Vivekananda Nagar, Salugara, P.O. Sevoke Road, Dist. Jalpaiguri regularly came into our house with his son namely Md. Anuarul Ali and offered to my mother on several occasion to sale our Landed house but on all occasions I objected to their proposal for sale of our Land and house.

That due to such reason, the abovenoted Md. Mantu Ali and Md. Anuraul Ali think that they have failed their planned for sale of our house due to objection of myself and as a result of which I am the enemy of them.

That today midnight at about 1:00 AM, said Md. Mantu Ali (my brother-in law) and his son Md. Anuarul Ali, entered into my house and when I was going for Toilet, said Md. Mantu Ali caught me with his bed intention and trying to modesty on my body and his son forcefully closed my mouth with his hand and telling me that if I shall not leave the house immediately, they will kill me. Not only that they threatened me with all consequences.

That said Md. Mantu Ali (my brother-low) is a man of greedy in nature and I am very much afraid and like that my life in danger and Md. Mantu Ali like to ousted me form our house forcefully.

I therefore humbly request you sir to kindly enquire into the matter and take necessary action against said Md. Mantu Ali and Md. Anuarul Ali to stop their interfere and entrance into our house for the safety of myself and our property and oblige me.


