I beg to state that I, **Sri.Pradip Kumar Jha** , S/o:Yogendra Jha, Resident of: Shastri Nagar, Ward No.41 ,SMC ,P.O :Sevoke Road ,P.S: Bhaktinagar ,District: Jalpaiguri. I and Smt. Biva Singh are the joint owner and in actual physical possession of the land measuring 3 Katha 14 Chattak by virtue of a Deed of Sale being Deed No- I-4803/2023 registered in the office of the Add. Dist. Sub-Registrar , Bhaktinagar , Jalpaiguri and subsequently while we are in possession of the below mentioned schedule land we found some miscreants named Gajab Lall Pradhan and his son Surendra Kumar Pradhan both Resident of: Lower Umchung , Legship, P.O & P.S: Legship, Dist: Gyalshing (West Sikkim) ,PIN: 737113 started disturbing my peaceful possession of the suit land and for this wrongful acts we have filed a Civil suit before the **Ld. Civil Judge(Junior Division) at Jalpaiguri being T.S No:524/2023** against Gajab Lall Pradhan and his son Surendra Kumar Pradhan. Right now I am in possession of the suit property and recently on 02/03/2024 I found some of the miscreants enter into my suit land and unloading bamboo stick in my suit plot I immediately told the person not to unload any bamboo stick in my plot and then I lock my gate and also pasted a photocopy of certified civil suit copy that a case is pending in the suit.

That 08/03/2024 at about 5 P.M I found Surendra Kumar Pradhan, S/o: Gajab Lall Pradhan removes the poster from my gate and also broke my lock and forcibly trying to enter into my suit property.

Then I immediately inform to your P.S and a **G.D.E being No: 407** dated 09/03/2024 was registered against the miscreant and subsequently on 10/03/2024 I again lock and key to my gate and again pasted a photocopy of certified civil suit copy but on 10/03/2024 the said miscreant named Surendra Kumar Pradhan, S/o: Gajab Lall Pradhan with other miscreants again removes the poster from my gate and also broke my lock with iron hammer and forcibly trying to enter into my suit property. Today I lodged this complaint as I am waited that any action was taken by your department but no fruitful result come so I again lodged the complaint on the incident on 10/03/2024 against the said miscreants so that the illegal acts may be check and also arrest the miscreants for continuing the illegal acts.

Therefore, I kindly request your goodself to register this complaint as, trespassing the suit property. I further request you to keep vigil on my property so that the said person did violate the Ld. Court order. I shall be grateful for your kind cooperation in this matter.
