The said post is found to have been uploaded in an YouTube by user namely "@surajitsahu9045" having channel ID" <https://www.youtube.com/@surajitsahu9045>". It is found to have publicised that only those who have passed Madhyamik from the recognized board of West Bengal Government can apply for the post of Civic Volunteer and the employed candidates will be given a monthly salary of Rs.9000/-.

Also, it is known from the said post that a large number of vacancies will be recruited from various districts of the state. Almost 35 thousand to 1 lakh vacant posts can be filled by the state government by recruiting eligible male and female candidates from all the districts of West Bengal state. Thereafter, the said post has received lots of comments and has been shared by number of people. The user uploaded the forged online document to intending harm the reputation as well as defaming the state and trying to mislead the general people with malicious intention.

Therefore, I request to you to arrange for the detail investigation of this post and to take lawful action against the mischief user of this post who might have made, published, circulated this post, rumour without any proper authenticity with an intent to cause public mischief.
