Sir,

I, Sri Tapas Bishui, Assistant Engineer(U) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Bikash Kunda, S/o- Lt. Birendra Nath Kunda, Ashutosh Mukherjee Road, Ration Shop, Back Side Mamata Stores, College Para, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 14.03.2024 at about 02.50 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the Commercial shop of Sri Bikash Kunda and inspected service installation, metering installation of Consumer ID 400619300 in the name of Sri Bikash Kunda. During inspection it was found that electricity was being used unauthorisedly & illegally by Bikash Kunda by reconnecting the disconnected service line of the metering installation that was disconnected previously on 27.02.2018 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make HPL-SOCOMEK Pvt Ltd, serial no.- P1926683 installed against Con Id. 400619300 seized by preparing a formal seizure list duly signed by Bikash Kunda and witnesses. The copy of the seizure list handed over to Bikash Kunda and his signature obtained as token of receipt.

As Bikash Kunda have committed offence u/s 135(1)(e) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
