Dear Sir,

I, Arpan Bhansali, Son of Shri Shanti Lal Bhansali, Proprietor of M/S Arpan Plumbing Mall, Situated at Burdwan Road, Near Silpanchal Bhawan, P.O & P.S Siliguri, Dist Darjeeling, Pin 734005, West Bengal, would like to lodge an FIR against **SHRI GOVIND YADAV** S/o Nathu Yadav resident of Santoshinagar, Siliguri stating as follows:

1. That I deal in business of supplying pipes, fittings, sanitary ware, bath accessories etc. since last many years and the above named miscreants is working in my firm for last many years.
2. That, I came to know that every day for the last few months my physical stock of items are not matching with that of my books and some of the items that I deal in are going missing for last few months and I was unable to track the missing items.
3. That today morning around 7am when I was walking around in front of my warehouse/office, I saw that above named **GOVIND YADAV** was coming out from my warehouse carrying a black bag on his back and walking towards his bike. On suspicious grounds I told him to stop and allow me to check his bag. But he did not stop and run away from there in his two wheeler bearing vehicle registration No.
4. That, immediately I rushed inside my warehouse to check if everything was ok, but to my shock I found that many packets of fittings items that I deal in were scattered and lots of them were missing.
5. That the items that are missing are in large quantity and small size items in nature so the exact missing items description will have to be calculated in due course of time.
6. That I even suspect that the above named miscreant have been cheating and stealing the items that have been missing from my warehouse since past few months.
