In producing herewith 01 (one) accused person namely Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following articles under proper seizure:-

One pink colour back pack styled as "SOHAM, Royal Star Bags" containing 30 (thirty) bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup "COUGREX" Cough Syrup containing 100 ml in each bottle (i.e. total 30 x 100 ml = 3000 ml) having Batch No TBHW0644, Mfg date 06/2023, Expiry date 05/2025, MRP Rs 170.50/- marked as Exhibit "A', I, SI Bandhan Roy S/O Nanda Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the accused person viz Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 10.03.24 at 22.15 hrs I, received a reliable specific source input that one person possessing huge quantity of illegal Cough Syrup without any valid license planned to come on foot near Methibari Petrol Pump under Pradhan Nagar PS, Dist.- Darjeeling to deliver the same to his designed customer.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No 566 dated 10.03.24 and I informed the matter to you in written. Subsequently, being directed by you myself along with SI Goutam Mallick, ASI Manoj Kr Roy, ASI Biplab Kr Das, C/1169 Prasenjit Barman and C/1411 Ashok Roy all of Pradhan Nagar PS, SPC left for Methibari Petrol Pump under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information at such late hour of night and not to afford him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No 567 dated 10.03.24 and M.C.C No 631/24 dated 10.03.24. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and directed him to come in front of Methibari Petrol Pump with his video camera for the purpose of videography if required. On the way I briefed all the police personnel sharing the information in hand and also informed night RT van officer ASI Sanjoy Sarkar of Pradhan Nagar PS and directed him to come in front of Methibari Petrol Pump to accompany with us.

At about 22.55 hrs, I along with above mentioned officers and force reached in front of Methibari Petrol Pump under Pradhan Nagar PS, contacted with my source while he stated that the person possessing illegal cough syrup would come opposite to Methibari petrol pump to supply illegal cough syrup to his designed customer. Then I contacted with two independent witnesses namely (i) Gaffar Islam S/O Late Md Masiruddin of Sukna Tea Estate, PO- Gulma, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Avijit Darjee S/O Late Uttam Darjee of C/O Karam Lama, Samarpan Rehab, Salbari, PS- Pradhan Nagar, Dist.- Darjeeling and informed them about the source input and requested them to act as witness, if any search and seizure would be made, upon which they agreed. I also issued notice to the said independent witnesses. At about 23.15 the above mentioned camera man arrived at the spot. Accordingly, I issued a notice to him for videography of the entire process of search and seizure if required. At about 23.40 hrs being pointed and identified by the source, I noticed one person coming from Salbari side on foot. At 23.45 hrs we managed to detain him with a back pack on his back in front of Methibari Petrol pump. Thereafter, we disclosed our identity as police personnel and informed him regarding the information in hand and stated him that he would be searched in person for the said purpose.

On interrogation, the detained person disclosed his identity as Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS – Pradhan Nagar and came there for delivering the same to his designed customer to fulfil his requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above.

Accordingly, I informed the matter to you and as per your kind order, I informed the fact to Shri Moksedur Rahaman, WBPS, ACP, SPC detailed for acting as Special Executive Magistrate of SPC for the day vide C.O. No 1188 dated 28.02.24 and Memo No 1636(15)GOA/SPC/V dated 28.02.24 regarding interception of the accused person suspected to possess illegal cough syrup and requested him to come in front of Methibari Petrol Pump under Pradhan Nagar P.S, Dist.- Darjeeling to remain present and to supervise the live search and seizure of the contraband items as well as to act as Spl, Executive Magistrate. At 00.55 hrs Shri Moksedur Rahaman, WBPS, ACP, SPC arrived at the spot in front of Methibari Petrol Pump. Then, I offered the independent witnesses and the detained person to search our Police Personnel as per provisions of law but they denied to search the police personnel. Thereafter, in presence of Shri Moksedur Rahaman, WBPS, ACP, SPC and independent witnesses noted above, I searched the detained person following all formalities, maintaining his strict regard of decency but found nothing except his wearing apparels. But on search of the pink colour back pack in his possession, recovered 30 (thirty) bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup "COUGREX" Cough Syrup containing 100 ml in each bottle (i.e. total 30 x 100 ml = 3000 ml) having Batch No. TBHW0644, Mfg date -06/2023, Expiry date - 05/2025, MRP Rs 170.50/ of each bottle. On demand in presence of Shri Moksedur Rahaman, WBPS, ACP, SPC as well as in presence of the independent witnesses, the detained person named Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS-Pradhan Nagar, Dist. Darjeeling failed to produce any valid document/papers for possessing or selling of such huge quantities of 'Codeine Phosphate' based Cough Syrup. On further grilling, he admitted his guilt and stated that he had procured the said Cough Syrup clandestinely from one of his suppliers for the purpose of selling the same in high rates to his designed and selected customers and also stated that he was waiting there for his customer to deliver the same for his personal gain by illegal means. He been dealing such type of illegal and harmful business of procuring and also disclosed that he has selling of cough syrup illegally for last few months for his wrongful gain.

Accordingly, I seized the said one pink colour back pack styled as "SOHAM, Royal Start Bags" containing 30 (thirty) bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup "COUGREX" Cough Syrup containing 100 ml in each bottle (i.e. total 30 x 100 ml = 3000 ml) having Batch No. TBHW0644, Mfg date -06/2023, Expiry date 05/2025, MRP Rs 170.50/- marked as Exhibit "A' under proper seizure list from the possession the accused person namely Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling in presence of Shri Moksedur Rahaman, and obtained their signatures and WBPS, ACP, SPC and independent witnesses noted above acknowledged by the accused person. Subsequently, I sealed and labelled the seized articles in presence of Shri Moksedur Rahaman, WBPS, ACP, SPC and independent witnesses and the above noted accused person. The whole process of search, seizure and label was made under the coverage of videography by the videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling in between 01.15 hrs to 02.25 hrs on 11.0.3.24. I informed the father of the accused namely Dilman Darjee S/O Late Kabiraj Darjee of Salbari Bazar PS- Pradhan Nagar, Dist. Darjeeling regarding arrest of his son in written.

From the above noted facts and seizure of incriminating articles, it is quite evident that the accused person namely Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act. Then, I arrested him after observing all formalities and informing him the ground of his arrest and issuing him Memo of Arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper section of law may kindly be started against the accused person Pradip Darjee (28 yrs) S/O Dilman Darjee of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
