Sir,
In producing herewith one accused person named Goutam Jha (27) S/O Gopal Jha of Majhura, PO+PS. Bahera, Dist. Darbhanga, Bihar under arrest along with the following articles under proper seizure :-

One paper made cartoon containing 11 (Eleven) bottles of EM BOSS Fine Whisky each bottle containing 750 ml i.e. total (11 x .750 ltr) = 8.250 ltrs, marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A-1".

I, SI Bandhan Roy of Pradhan Nagar PS, SPC would like to lodge this written complaint against accused person named Goutam Jha (27) S/O Gopal Jha of Majhura, PO+PS. Bahera, Dist. Darbhanga, Bihar to the effect that today on 12.03.2024 at 18.30 hrs I along with force left the PS to perform special mobile RT van duty vide Pradhan Nagar PS GDE No. 677, dated 12.03.2024. During my duty at 20.20 hrs I received a specific source information that one person carrying huge quantity of illicit liquor without any valid license is standing at Siliguri Junction and waiting for a Bihar bound Bus. Accordingly, I am sharing the information with you.

As per your kind order and direction, I along with ASI Biplab Kr Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS arrived at Siliguri Junction under Pradhan Nagar PS to verify the veracity of the source information. On reaching there I contacted with my source and being identified by him I detained one person with a paper made cartoon in his possession. On being asked the detained person disclosed his identity as noted above and also disclosed that he carrying illicit liquor illegally to sell the same at Bihar for his wrongful gain and also stated that he is waiting for a Bihar bound bus. On search the paper made cartoon in his possession recovered 11 (eleven) bottles of EM BOSS Fine Whisky each bottle containing 750 ml inside the said paper made cartoon. On-demand he failed to produce any valid license/papers for carrying of such articles. On further interrogation, he stated that he had been involved in carrying and selling liquor without any valid license for his illegal gain. Then, I seized and labeled the above-mentioned illegal illicit liquor under the proper seizure list from his possession and marked as Exhibit "A" and subsequently, arrested the above-mentioned detained person namely Goutam Jha (27) S/O Gopal Jha of Majhura, PO+PS. Bahera, Dist. Darbhanga, Bihar after observing all sorts of formalities on the spot. The whole process of seizure and label was made in between 21.15 hrs to 22.10 hrs at the spot for violating the norms of the Bengal Excise Act.

I, therefore pray before your good self that a specific case may kindly be initiated against accused Goutam Jha (27) S/O Gopal Jha of Majhura, PO+PS. Bahera, Dist. Darbhanga, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
