Respected Sir,

Most humbly, my name is Rabindra Mahato son of Ramsagar Mahato and I am resident of Bagajatin Colony ,Siliguri , P.O & P.S :- Pradhan Nagar . I write this letter to lodge a complaint regarding my Cousin brother being beaten badly by Mr Sanjit Kumar Ray ,Son of Late Shivji Rai (owner of Rajesh Hotel In regulated Market Area) and by all his staffs.

Sir today at around 1 pm my brother Mr Alok kr Prasad went to meet with Mr Sanjit Kumar Ray as he was supposed to give my due amount of Rs 4,00,000/- as promised by him but after reaching the spot I saw that an altercation took place between Sanjit kumar ray and my brother Alok kr Prasad after which sanjit kumar and all his staffs began to beat my brother badly with rod and sticks after which which my brother became unconscious and was rushed to the nearby Siliguri District Hospital by us. During the altercation Sanjit kumar ray and his staffs looted Rs 1,10,000/- cash from his pocket and gold chain from my brother's neck when he was in unconscious state.

Sir currently my brother is admitted in the District hospital as he has sustain lot of Injuries and I request to you book the accused Sanjit kumar Ray under Indian Penal Code 307.

This is to request you to kindly take our FIR and arrest Mr Sanjit Kumar Ray and all his staffs for conduction such crime so that the fear of law prevails among the society.
