Sir,

I Rudranil Das (21 yrs) S/O Goutam Das resident of Adarpara, Ward No-11, PS- Kotwali, Dist. Jalpaiguri beg to inform you that my father has been working in a private firm styled as Jagannath Traders situated at Debidanga Bazar under PS- Pradhan Nagar, Dist. Darjeeling. On 07.03.24 at about 09.30 hrs my father was standing in front of the said shop while one vehicle having registration number WB/74/BL/1950 badly dashed my father, causing my father sustained serious injury. Immediately local people shifted my father at Pulse Hospital, Champasari where he was treated till 09.03.24. On 09.03.24 he was released from Pulse Hospital and was shifted to Super speciality Hospital, Jalpaiguri as his condition was getting serious. So he was transferred to North Bengal Medical College & Hospital on 13.03.24 for better treatment. I was engaged for my father's treatment. Hence, I was unable to lodge complaint in due time.

Therefore, I pray to your good self to kindly investigate the matter and take legal action as per law and highly obliged thereby.


