

Sir,

In producing herewith (05) five arrested accused persons namely (i) Nima Tshering Sherpa (30 yrs) S/O Late Jai Brd Sherpa of Sonada Bazar near Petrol Pump, PS- Jorbanglow, Dist.- Darjeeling (ii) Bikash Kumar Gungan (36 yrs) S/O Late Bindeswar Prasad Yadav of Durtarpur near Mustafapur Kabarsthan, PS- Goraul, Dist.- Baishali, Bihar (iii) Ajay Dey (20 yrs) S/O Bhabesh Dey of Biswas Colony, Matigara, PS- Matigara, Dist. Darjeeling A/P Simultala, PS- Matigara, Dist. Darjeeling (iv) Subham Pradhan (29 yrs) S/O Late Man Bdr Pradhan of Samser Busty, Gidde Pahar, PS- Kurseong, Dist.- Darjeeling and (v) Mithilesh Kumar (23 yrs) S/O Kailash Mahato of Birsha Munda Ground, Naya Bazar, South Palash, PS- Pradhan Nagar, Dist.- Darjeeling permanent address Mustafapur Chowk, PS- Goraul, Dist.- Baishali, Bihar under arrest and the following articles under seizure :-

(i) One iron made weapon locally called as "Bhojali" measuring 18 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Nima Tshering Sherpa (ii) one iron made sharp cutting weapon locally called as "Showrd" measuring approx 22 inch in length including wooden butt and one sharp cutting knife recovered and seized from the possession of accused Bikash Kumar Gungan (iii) one iron made sharp knife and one iron rod recovered and seized from the possession of accused Ajay Dey (iv) one iron made weapon locally called as "Khukri" measuring approx 18 inches in length recovered and seized from the possession of accused Subham Pradhan and (v) one sharp cutting knife and one torch light recovered and seized from the possession of accused Mithilesh Kumar. I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 05 (five) arrested accused persons and their 03/04 unknown associates who involve in this crime to the effect that on 15.03.2024 night at 00.35 hrs received a specific source information that about 07/08 persons assembled at Birsa Munda Ground, South Palash, under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoity at Samar Nagar area.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 805 dated 15.03.2024. After getting the permission from you myself along with ASI Jagannath Roy, ASI Monaj Kr Roy, ASI Biplab Kr. Das, C/1411 Ashok Roy, C/1415 Chandan Basak, C/1416 Dilip Barman and C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Birsa Munda Ground, South Palash under Pradhan Nagar PS to verify the veracity of the information. On the way, I informed the matter to RT van officer ASI Md Anwar Abedin of Pradhan Nagar PS and directed him to come at Birsa Munda Ground, South Palash to accompany with us for holding raid at Birsa Munda Ground, South Palash. At about 01.05 hrs we reached at Birsa Munda Ground, South Palash, and at around 01.15 hrs night RT van officer ASI Md Anwar Abedin along with his RT van force arrived at Birsa Munda Ground, South Palash, and accompanied us. Then I shared the information to all the above noted officers and force and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 07/08 persons assembled in a dark place at Birsa Munda Ground, South Palash and they were whispering in a very low voice. We cordoned the place with due care and caution.

On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted five (05) accused persons with deadly weapons in their possessions while 03/04 others managed to flee away from the spot taking the opportunity of darkness and open place. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Samar Nagar area. Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.45 hrs to 02.35 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the five (05) arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Samar Nagar area.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted 05 accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Samar Nagar.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted five (05) arrested accused persons (i) Nima Tshering Sherpa (30 yrs) S/O Late Jai Brd Sherpa of Sonada Bazar near Petrol Pump, PS- Jorbanglow, Dist.- Darjeeling (ii) Bikash Kumar Gungan (36 yrs) S/O Late Bindeswar Prasad Yadav of Durtarpur near Mustafapur Kabarsthan, PS- Goraul, Dist.- Baishali, Bihar (iii) Ajay Dey (20 yrs) S/O Bhabesh Dey of Biswas Colony, Matigara, PS- Matigara, Dist. Darjeeling A/P Simultala, PS- Matigara, Dist. Darjeeling (iv) Subham Pradhan (29 yrs) S/O Late Man Bdr Pradhan of Samser Busty, Gidde Pahar, PS- Kurseong, Dist.- Darjeeling and (v) Mithilesh Kumar (23 yrs) S/O Kailash Mahato of Birsha Munda Ground, Naya Bazar, South Palash, PS- Pradhan Nagar, Dist.- Darjeeling permanent address Mustafapur Chowk, PS- Goraul, Dist.- Baishali, Bihar and others 03/04 unknown miscreants and arrange for its investigation.
