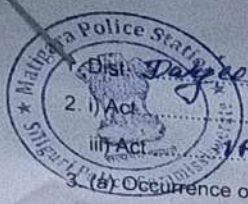

I, Smt Sangita Biswas, Wife of Sri. Haradhon Biswas, Resident of Kawakhali, Near Fish Bazaar, P.O. Sushrutanagar, P.S. Matigara, Dist- Darjeeling, would like to inform that my husband is a Gas Cylinder Delivery man presently working for gain at Narayani Indane Gas Agency at Jhankar More, P.S. Khalpara T.O.P, Dist Darjeeling and today i.e, on 14/03/2024 at about 03:10 p.m. when my husband returned home after delivering Gas cylinders, some miscreants namely 1) Lalmati Devi Shaw, 2) Roshan Shaw, 3) Samir Shaw and 4) wife of Samir Shaw, all residents of Kawakhali, Near Fish Bazaar, P.O. Sushrutanagar, P.S. Matigara, Dist- Darjeeling, came in front of our house and started to scream and call my husband and started to abuse with filthy languages and threaten my husband for delaying in delivery of Gas Cylinders at their house and when my husband tried to confront them all of them started to hit my husband with fists and blows and also hit him with bamboo sticks and tried to choke him with the intention to kill my husband and also snatched the collection amount of Rs. 15,000 (Fifteen thousand) only from husbands pocket which he collected after delivering the gas cylinders to the consumers and when I rushed to rescue my husband said Samir Shaw and Roshan Shaw hit me with fists and blows and also kicked me in my belly and tore my nighty dress with the intent to outrage my modesty and also snatched the gold chain from my neck and when I shouted for help and hearing my scream when my son namely Snehasis Biswas aged 17 came to rescue us they even punched him in his eyes and face and pushed him as a result he fell down and thereafter they started kicking him. And seeing this when I shouted for help the neighbours came and helped us and then they fled away and while going they threatened us with dire consequences. Thereafter I along with my husband took our son and rushed to the hospital for treatment, hence the delay in lodging this complaint.

Presently I and my family is in fear of life and limb. So, Please kindly set the law of land in motion and impart me justice.
