Respected Sir,

With due respect, I, Smt Maya Thapa, D/O Late Om Bahadur Thapa, resident of Mahananda Para, Near Mahananda Sporting Club, Ward No 4, SMC P.S Siliguri Khalpara Top, Dist Darjeeling would like to inform you that I reside at my parental house with my daughter Namita Karki after few months of my marriage I got separated with my husband and I used to earn my livelihood by various means even I went to foreign countries to earn money, during that period I used to help my younger brothers and sister namely Dhanu Thapa and Devi Thapa and others. On various occasion they took loan from me, Later on I came back to my home town and started my tea stall business in front of my house.

That my father Om Bahadur Thapa died on 29.10.1989 and my mother Deu Maya Thapa also died on 12-07-2020. It is mention here that my brothers, Gopal Thapa, Kalu Thapa, Dhanu Thapa, Arjun Thapa, Lila Thapa, and their wives started torturing me and my daughter for the property and forced me to leave the house and my share of the property.

That my younger sister Devi Thapa and her husband Pratap Bhujel, who are also residing at my parental house abused me with filthy languages, throw hot tea upon my daughter. Again 5 months ago Pratap Bhujel hitted me with fist and blow and in the month of June 2023 Dhanu Thapa has beaten me with plastic bucket upon my chest and felt unconscious and was in bed rest for many days.

That on 25.10.2023 at about 12 noon all of them gathered together for my fathers death anniversary, all of a sudden Dhanu Thapa hit me with iron rod I then and then called 100 dial, by hearing that Dhanu Thapa fled away, it is mentioned here that before also

Pratap Bhujel and Dhanu Thapa and Gopal Thapa tried to kill me and my another sister Manika Thapa .

That my brothers 1) Kalu Thapa 2) Gopal Thapa, 3) Dhanu Thapa, 4) Lila Thapa, 5) Arjun Thapa who attacked and beat me and my sister Manika Thapa who was seriously injured and after this incident she had gone to Delhi and they speak with us in dirty speech to me and my daughter on 15/03/2024.

That my small sister Manika Thapa who was not in her room and she went to Delhi for her job to keep her Godrej Almirah in her brother Kalu Thapa's room and after completed her Job she came to house on 29/02/2024 and saw that there was no Godrej Almirah in Kalu Thapa's room and Kalu Thapa had thrown the said Godrej Almira in the Srcap Room and there was not found anything in the Almira like Hotel Utensils and some documents and Rs.20,000/-

That Dhanu Thapa also misbehave with me and attacked many times and he had broken my Almira and made a hole on the Alira and after this my Ornaments and Rs. 10,000/- had been lost.

It is pertinent to mention here that my above named brothers and sister Debi Thapa and her husband Pratap Bhujel conspires with each other for not giving any share of my parental properties. to me and my sister Manika Thapa . and also the loans taken by them from me.
