Bagdogra, District Darjeeling, Pin-734014, West Bengal, India would like to state that my neighbour namely **Manoj Indwar**, S/o. Jagannath Indwar, R/o. Ho-Chi-Min Nagar (Lichu Bagan), Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling always quarrel with me & uses bad & filthy language. Today i.e. on 14.04.2024 at about 4.00 P.M. when I was at my home I saw some labours working at my land & when I objected the said labours, my neighbor **Manoj Indwar** hit me in my head with iron rod with an intension to kill me. Due to the said assault I sustained injuries in my head. I anyhow managed to get rid of his cruel hands & went to Bagdogra PHC for treatment. The main intension of **Manoj Indwar** & his family members is to throw me from my land or kill me so that they can enjoy my residential land. This person has earlier also threatened me. I am in pain & fear as **Manoj Indwar** is a ferocious person and he can do anything to me for the said land. I am a alone lady aged about 50 years & finding me alone **Manoj Indwar** can again try to kill me.

It is requested before you in folded hand to kindly take strict necessary action against the abovenamed person **Manoj Indwar** so that he can be stopped.
