In producing herewith following accused persons namely (i) Ajgar Ali (M/24), s/o- Moktar Hossain of Moyna Check Post, PO- Barogram, PS- Harirampur, Dakshin Dinajpur, (ii) MD Sukat (M/24), s/o- MD Muslim of Tiger Basti, Station More, PS- Bagdogra, Dist- Darjeeling, (iii) Mukesh Chowdhary (M/27), s/o- Dani Chowdhary of Station More Railway Colony, PS- Bagdogra, Dist-Darjeeling & (iv) Naresh Roy (M/28), s/o- Moti Roy of Bhujiyapani Jot, PS- Bagdogra, Dist- Darjeeling under custody along with following seized articles:

- (i) One iron made rod (shabal) having length 2'4" from the possession of accd Ajgar Ali in right hand.
- (ii) One iron made knife having body length 6', butt length 4'' from the possession of accused MD Sukat from right waist.
- (iii) One iron made sword having total length 35" from the possession of accused Mukesh Chowdhary.
- (iv) One nylon rope having total length 14'5" from the possession of accused Naresh Roy.
- (v) One Evaredy steel colour torch light from the possession of accused Naresh Roy.

I, SI Debabrata Kundu of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested four accused persons and others to the effect that today on 16.03.2024 at 01:25 hrs I received reliable source information that some persons are assembled near Gossainpur Railway underpass near Charakmath under Bagdogra PS and they have been preparing to commit dacoity. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide GDE No. 771 dated 16.03.2024 and a formed a raiding team consisting ASI Munna Ahmed, CV/386 Kishor Ranjan Hawladar, CV/375 Jogesh Barman leaded by me. Then at 01:35 hrs as per direction, we left for Gossainpur Railway underpass near Charakmath under Bagdogra PS to work out the secret source information. This refers to Bagdogra PS GDE No. 772 dated 16.03.2024. On the way we contacted with night mobile van officer ASI Jahangir Ali and informed them to come near Gossainpur Railway underpass near Charakmath to accompany us. At around 01:55 hrs we reached near Gossainpur Railway underpass near Charakmath under Bagdogra PS and made an ambush there. We parked our Govt. vehicle away from the place. Being shown & indication by source we saw a group of about 12/13 persons there. We started to encircle them from all side. All on a sudden some of them noticed us and tried to flee away from the spot. But after hot chase we managed to apprehend four suspects there in red-hand and searched their persons. They were armed with deadly weapons and equipments to commit dacoity, house breaking etc. Accordingly, we interrogated them. On interrogation, they could not give any satisfactory answer regarding their presence at that place at the odd hours of night. They gave different statement in different times. On interrogation, they revealed their identity as (i) Ajgar Ali (M/24), s/o- Moktar Hossain of Moyna Check Post, PO- Barogram, PS- Harirampur, Dakshin Dinajpur, (ii) MD Sukat (M/24), s/o- MD Muslim of Tiger Basti, Station More, PS- Bagdogra, Dist- Darjeeling, (iii) Mukesh Chowdhary (M/27), s/o- Dani Chowdhary of Station More Railway Colony, PS- Bagdogra, Dist- Darjeeling & (iv) Naresh Roy (M/28), s/o- Moti Roy of Bhujiyapani Jot, PS- Bagdogra, Dist- Darjeeling. Finally, they confessed that they were assembled there in order to commit dacoity at Gossainpur area. Rana Chettri of Tiger Basti, Rithik Mishra of Bhujiyapani & others were also there but somehow they managed to flee away. They were armed with deadly weapons and equipments to commit dacoity, house breaking etc. No independent witness could be found available there at the odd hours of night. Accordingly, I seized those articles (deadly weapons and equipments) viz. one iron made rod (shabal), one iron made knife, one iron made sword, one nylon rope & one Evaredy steel colour torch light from their joint possession under proper seizure list & label in presence of police witnesses. Finally, I arrested them after telling them the ground of arrest and issued memo of arrest in this regard. The process of search, seizure, label & arrest was made in between 02:15 hrs & 03:15 hrs.

Under the above fact & circumstances, I request you to initiate a specific case under proper sections of law against the above mentioned involved arrested accused persons & other absconding accused persons including Rana Chettri of Tiger Basti, Rithik Mishra of Bhujiyapani and arrange for its investigation.
