Respected Sir,

With due respect and humble submission, I, Abhinata Das, Daughter of Mr. Kamal Chandra Das and Rev. Jocinta Kamala Das, resident of Sukanta Pally, Siliguri Municipal Corporation, District: Jalpaiguri, West Bengal, PIN: 734005 near Chalantika Kali Bari got married to **Biswajit Das** alias **Bishu**, son of Nirmal Das and Mrs. Aroti Das resident of of Sukanta Pally, Siliguri Municipal Corporation, District: Jalpaiguri, West Bengal, PIN: 734005 near Chalantika Kali Bari, on 18th of April, 2008. As I got married with Biswajit Das and later did the registry, since from beginning my in-laws kept me torturing physically and mentally for dowry and my religion as I was Christian. However my parents gave me enough jewelry (gold) during my marriage. I also converted to Hinduism and followed everything. After the birth of our daughter Bidisha Das on 18th of March, 2012, they kept me torturing, but I didn't lose hope and stayed strong as a Daughter-in-law. However, their greed never stopped. My husband (Biswajit Das) used to come intoxicated, torture me and physically assaulted me. Still, I stayed and fulfilled my duty as a daughter-in-laws, my parents never interfered in my married life. During pandemic lockdown I discovered that my husband, Biswajit Das has an illegal affair with a lady, regarding which an FIR has been lodged. My husband abandoned us during lockdown and I was forced to move to my mother's house in M. M. Terai, PO: Belgachi, District: Darjeeling, 734423. My daughter was studying there in M. M. Terai. After the lockdown they came and tried to take our daughter Bidisha Das with them, to which I didn't agree. Than after few meeting my Sister-in-law Peu Sarkar (Das) convinced me to go with them and assured me that I will not be tortured and humiliated again, therefore I went. Again after I went to my in-laws house they again started torturing me by forcing me to ask my mother and brother for my daughter's and my allowances, for which I denied. Since then, my husband **Biswajit Das**, Sister-in-law **Peu Sarkar (Das)**, Mother-in-law **Aroti Das** and father-in-law **Nirmal Das** started torturing me physically and mentally. My husband
