With due respect, In producing herewith two accused persons namely (1) Amjad Ali (38) s/o Lt. Kadam Ali of Singhimari kuch gaon PS Dhekla Joli Dist. Sonetpur , Assam and (2) Aynal Haque (26) S/o Ajgar Ali of No. 1 Joyma PS Gosai gaon Dist. Kukurajhar , Assam following seized vehicles loaded with cattles as per proper seizure list :-

1. One Vehicle (Truck) having Registration No. AS-25-EC-0385 .
2. 17 (seventeen) numbers of Cows and 14 (Fourteen) numbers Calf in different color and different size which carrying in the Vehicle bearing No. AS-25-EC-0385.

I, ASI Alokesh Raha Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint to the effect that on 11.03.24 at 21-55 hrs myself alongwith force left for performing night mobile van duty vide NJP PS GDE No. 557 dt. 11.03.24 and on 12.03.24 at about 01-30 hrs I received a secret source information that one vehicle are being loaded cows illegally coming form Ghosh pukur side towards Assam through Fulbari Jalpaiguri without any valid documents/papers and if immediate action is taken , it can be apprehend . Accordingly I shared the information to duty officer and OC NJP PS. Thereafter as per his direction myself alongwith force left for Fulbari Toll gate to verify the veracity of information vide . At 02-05 hrs we reached at Fulbari near Toll gate and on the basis of secret information we intercepted the one vehicle and apprehended two persons from that vehicle. On asked they disclosed their name and address mentioned above which not verified as they could not produce any supporting documents in respect of their identity . On checking the vehicle we found that total 31 numbers of cows including 14 numbers Calves in different color and size were loaded on the said vehicle. On further checking it was found that there was no arrangement made for food and water for the Cattle as per govt. rules which they was carrying in that vehicle. Besides, this there was no sufficient space for the cattle in that vehicle and all of them were tied with ropes. On interrogation the both confessed their guilt and stated that they were carrying the cattles from Bihar illegally for the purpose of selling the same at their native place area to earn huge money illegally. It is reason to believe that both the accused person of the vehicle were carrying the cattles by means of theft without any valid documents/papers illegally . Accordingly I seized One Vehicle (Truck) having Registration No. AS-25-EC-0385 and (2) 17 (seventeen) numbers of Cows and 14 (Fourteen) numbers Calf in different color and different size which carrying in the Vehicle bearing No. AS-25-EC-0385 under proper seizure list in presence of witnesses. The drivers of the above noted seized vehicle are violated The Prevention of Cruelty to Animals Act 1960. The seized cattles handed over to the Fulbari Khoyar for safe custody. The seizure was made in between 02-25 hrs to 03-45 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against (1) Amjad Ali (38) s/o Lt. Kadam Ali of Singhimari kuch gaon PS Dhekia joli Dist. Sonetpur , Assam and (2) Aynal Haque (26) S/o Askar Ali of No. 1 Joyma PS Gosai gaon Dist. Pukurajhar , Assam the drivers of the above noted seized vehicle AS-25-EC-0385 to arrange for its investigation.
