Darjeeling, would like to inform you that I booked my gas cylinder on dated 06/03/2024 over mobile phone and delivery date 09/03/2024 but I did not get on due time after that my son phoned to delivery person/agent to inform all the incident for not getting the gas cylinder and also go to the Gas office to registered a complain. But on 13/03/2024 (yesterday) at about 3.00 P.M. to 3.30 P.M. (After noon) Haradan Biswas (Gas cylinder delivery agent/person) son of Unknown, along with his wife namely Smt.
