Would like to lodge this written complaint to the effect
that I got married with one Anup Malakar (now
deceased) on 29.08.2001 at Kalibari, Jalpaiguri and
after my marriage I came to my matrimonial house
at above mentioned address and everything was going
smoothly and I was spending my life happily and
I gave birth to my elder son on 02.07.2002 and
thereafter in the year of 2013 we came to know
that my husband was suffering from cancer last stage and
and at that point of time I was carrying my
2nd pregnancy and after the birth of my younger
son on 06.08.2013 my husband was in hospital
and after elapse of one month my husband died
at NBMCH on 13.09.2013.

Sir, it is to be mentioned here that husband
of my sister in-law namely Tapas Saha, s/o Late
Ananda Saha, resident of Shirampally, Haider Para,
P.S. Bhaktinagar, Dist - Jalpaiguri used to keep his
lustful eyes on me as my husband was
bedridden.

and on multiple times he has expressed his ill intention towards me.

Sir, it is to be mentioned here that this Tapas Soha used to record my videos and clicked my photos when I used to take bath in bathroom and when I raised my objection to his such act he used to blackmail me by saying to make viral the photos and videos.

Sir,

It is to be mentioned here that after the demise of my husband my parents in-law expressed their desire to sell the house and they also assured me that they will pay me the amount/share of my husband on monthly basis. and in exercise of the agreement I used to visit the house of my parents in-law on 15th day of every month and they used to give me Rs. 6200/- only per month.

Today, i.e. on 15.03.2024 I went to their rented premises for bringing the amount and I was talking to my mother-in-law at that point of time the above mentioned Tapas Soha came and requested me to come to the separate room with an ill motive and when I refused to go with him in the room he threatened me that he will not let my parents in-law to pay the monthly money

and video viral in the internet which he had
clicked previously. and when I started
shouting upon his such act he started to
assault me physically by fists and blows and
he brought scissor from another room and
attacked upon me by touching my private
body parts but at the same time the other
in-law members came and somehow rescued
me from the clutches of the above mentioned
Papao Saha and thereafter my mother came
and took me to Siliguri Hospital.

It is to be mentioned here that during the
stay at my matrimonial house the above
mentioned person has outraged my modesty
and touched my physical parts and always
threatened me to make viral the photos and
videos.

Therefore, I request you to kindly lodge
a specific case against the above mentioned
person.
