I, SI Tanmay Kundu of NJP PS, Siliguri Police Commissionerate , do hereby lodge written complaint, on producing one arrested accused person namely Gopal Saha (38 yrs) S/O Lt. Anath Saha of Bholanath para Ashigharh PS Bhaktinagar Dist.- Jalpaiguri under arrest along with following seized

- Eighteen (18) sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as
- Six (06) sealed Bottles of Haywards 5000 Premium Strong Beer, each bottle 650 ml, Marked 2. as Exhibit-B from which O1 bottles taken as sample for examination Marked as Exhibit-B1.

I am submitting a written complaint against the above noted accused person to the effect that 15/16.03.24 at 22-25 hrs myself alongwith C/1462 Sajan Tamang, CV-306 Biswajit roy , CV-297 Putul Roy were performing night Spl. Mobile duty vide NJP PS GDE No. 758 dt. 15.03.24 and during mobile duty at 23-35 hrs received source information that one person was selling Liquor illegally from his shop without named situated at Jabravita Housing under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith force all of NJP PS, SPC left for Jabravita Housing to verify the veracity of information. On arrival at the spot at 23-45 hrs it was found that one person mentioned above was selling liquor illegally from his shop at Jabravita Housing to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally from the his shop without any license. Thereafter in presence of witnesses I recovered eighteen (18) sealed Bottles of Himalayan gold country spirit 60up, each bottle 600 ml and Six (06) sealed Bottles of Haywards 5000 Premium Strong Beer, each bottle 650 ml from his possession from his shop and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 23-45 hrs to 00-25 (seizure Total approx 14.7 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Gopal Saha (38 yrs) S/O Lt. Anath Saha of Bholanath para Ashigharh PS Bhaktinagar Dist.= Jalpaiguri and arrange for its investigation.
