In producing herewith (04) four arrested accused persons namely (1) Jayanta Mohanta @ Kathal (31yrs)S/O-Lt. Ram Mohanta of Durga Das Colony, ward No-20, PS-Siliguri, Dist- Darjeeling (2) Tapash Mohanta (23yrs)S/O- Lt. Ram Mohanta of Durga Das Colony, ward No-20, PS-Siliguri, Dist- Darjeeling(3) Palash Mondal (28 yrs) S/O- Lt. Pujun Mondal of Dabgram near Tarun Tirtha Club, ward No-23, PS-Siliguri, Dist- Darjeeling and (4) Deepak Paswan @ Motra (31 yrs) S/O- Pudul Paswan of Uttar Bharat Nagar, ward No-24, PS-Siliguri, Dist- Darjeeling arrested on 17.03.24 u/s-41 Cr.P.C along with following seized articles viz: -

- 1. One iron rod measuring about 20inch (approx) from the possession of accused Jayanta Mohanta @ Kathal which was kept on his right hand.
- One iron rod measuring about 22 inch (approx) from the possession of accused Tapash Mohanta which was kept on his right hand.
- One iron made Knife approx 8 inch from the possession of accused Palash Mondal which was kept on his right waist.
- 4. One iron made Knife approx 7 inch from the possession of accused Deepak Paswan @ Motrawhich was kept on his right waist.

I, PSI Koushik Raha S/O-Jitendra Raha of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 17.03.24 at 02.10 hrs received a sources information that 8/9 youths have assembled at Air view more near Mahananda River bed under Siliguri PS for making preparation to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No.1285 dated 17.03.24 Subsequently after sharing the information with my superiors and as per their direction, at 02.15 hrs myself along with ASI Rabin Lama (Van officer), ASI Debasish Das, ASI Subir Sen, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with kits left for the place to work out the information. This refers to Siliguri PS G.D.E No. 1286 dated 17.03.24. We reached at Air view more near Mahananda River bed under Siliguri PS at 02.30hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 04 (four) accused persons along with seized articles as mentioned above. However, the other four/five persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area. They also stated that another four/five others fled away from the spot in which one Ajay, Ananda, Munna and two others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was

made in between 03.15hrs to 04.25hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.p.c under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Jayanta Mohanta (2) Ward No-20, PS-Siliguri, Dist-Ward No-20, PS-Siliguri, Dist-Ward No-20, PS-Siliguri, Dist-Ward No-20, PS-Siliguri, Dist-Ward No-20, PS-Siliguri, Dist-Darjeeling (2) Tapash Mohanta (23yrs)S/O- Lt.
