I Smt. Pooja Singh, W/o Sri Rabi Singh, resident of Gandhinagar, near the House of Ex-Councillor Sri Dilip Singh, P.O. - Sevoke Road, P.S. - Bhaktinagar, District - Jalpaiguri, would like to inform you that I am the owner in possession of all that piece or parcel of road side PWD land and katcha structure, having Holding No - 530/474 (2), measuring about 18 ft X 38 ft = 684 Sq. Ft. situated at Burdwan Road, Opposite Silpanchal Bhawan, SMC Ward No 9, P.O. & P.S. - Siliguri, District - Darjeeling by virtue of a deed of transfer of possession dated 22 - 3 - 1999 duly executed by one Sri Narayan Modak who was the possessor of the said land and since the date of such transfer of physical possession of the said land, I am possessing and enjoying the same freely and openly by running the business of Motor parts through my husband Sri Rabi Singh. The adjacent shop keeper of my shop is Suman Kalyan Pradhan, S/o Late Padam Prasad Pradhan, resident of Agomoni Abasan, Block E - 2, Dangipara, P.O & P.S - Siliguri, District-Darjeeling has obtained a fake Holding No - 1269 from Siliguri Municipal Corporation in respect of my said Land and Katcha Structure by suppressing the fact that the Holding No - 530/474 (2) has all ready been issued in my name by the Siliguri Municipal Corporation and on the strength of the said fake Holding, has also obtained trade license in the name of Galaxy Furniture and the said Suman Kalyan Pradhan has shown to be the proprietor of the said Galaxy Furniture not only that he also obtained an illegal electricity connection in his name. The said Suman Kalyan Pradhan by manipulating and tempering the Govt record of Siliguri Municipal Corporation has obtained the Holding No - 1269 in his name not only that by showing the said fake holding number has again manipulated the Govt record to obtain a fake trade license in the name of Galaxy Furniture to cheat me and the Govt of West Bengal and has tied to evict me from my premises on the strength of the said Fake Holding and fake trade license.

Be it mention here that on my complaint dated 1 - 11 - 2023 before the Commissioner, Siliguri Municipal Corporation, a proceeding having Memo No - 61 (2) / TL / SMC / 2023 - 2024 dated 29 - 2 - 2024 was started against the said Suman Kalyan Pradhan and the L.d. Commissioner was pleased to hold that the said Suman Kalyan Pradhan has declared that the Holding No - 1269 is a fake one and has also pleased to cancel the trade licence of Suman Kalyan Pradhan which he obtained in the name of Galaxy Furniture.

From the act of Suman Kalyan it is well established that he tempered the Govt. Record for his illegal gain and wrongful loss to me as well as the Govt of West Bengal and has tried to cheat me with intention to evict me on the strength of the said fake holding number and trade licence.

So requesting you to investigate the matter and take necessary legal action against the said Suman Kalyan Pradhan and oblige me.
