Sir,
This is to inform you that Majharul Haque Ansari, bearing roll no:- 3422765 of PSC WB Exam for recruitment to the post of SI in the subordinate Food & Supplies service, Grade III under Govt of W.B-2022 by PSC in the Vth session, dated 17-03-2024 and another candidate namely Md. Nawaz Sharif- s/o. SK Kuddus Alam bearing roll no:- 3423021 of PSC WB Exam for recruitment to the post of SI in the subordinate Food & Supplies service, Grade III under Govt of WB-2022 by PSC in the Vth session, dated 17-03-2024, both has been caught red handed using mobile phone inside the examination hall no. 09 and hall no. 17 respectively at the start of the exam.

It has been found in both their mobiles that a strong network is connected to both of the above mentioned candidates.

We, therefore, lodge an FIR against Majharul Haque Ansari and Md. Nawaz Sharif for adopting this unfair means in the exam hall. Further, it is to be mentioned that Majharul Haque Ansari fled physically from the venue taking advantage of gathering, so his undertaking statement could not be taken by us.
