Respected Sir,

I, Ghanshyam Prasad, son of Late Ram Lakhan Prasad ,resident of Rangpo Bazar , Dist – Pakyong , East Sikkim , and also residing at Shastri Nagar, Ward No. 41, P.O- Sevoke Road, P.S- Bhaktinagar, District- Jalpaiguri, would like to inform you that,

I along with my two brother namely Radheshyam Prasad and Manoj Prasad(now deceased) is the Absolute Owner of the Land measuring 6 katha 14 Chataks, in R.S khatian No. 701/5 sheet No. 8, comprising of plot No. 633, situated within Pargana Baikunthapur, Mouza- Ddbgram, P.s Bhaktinagar which we had purchased from Sri. Ganesh Chandra Paul and ors, in the year 2002, vide Deed No. 5355. That since then we are enjoying our land free from of all encumbrances . That we have muted our land in record of right and also paying land khajana to the concerned authority .And also having electric connection in name. That we have also constructed boundry walls on the said land from all the four corners with iron gate .

That yesterday on dated 15/03/2024 at about 5pm I when to repair my boundary wall the aboven named persons namely Manoj Gupta son of Mani Gupta, Prakash Singh, and Jitendra Singh @ Jitu Son of Naresh Singh, and his associates suddenly came to the spot and claim that the said land is there land and demanded sum of Rs 5,00,000 (Five Lakhs) and

threatened me in a word that if you want to construct a house in the said land you have to pay the said amount to us . That when I denied to pay the said amount the above name person Manoj Gupta caught me and other two Prakash Singh and Jitendra Singh@ Jitu assaulted me with Iron Rod of which I got injury in my stomach and became senseless. And they also mis handle my relatives. That today morning when I again went to visit my land , our Iron Gate which was fixed with wall has been stolen and some iron rod was also missing That I have a strong suspicion that the above name persons have taken my main Gate and iron rod, and also some construction Material is also missing from my land.

It is pertinent to mention here that we are living far away from the land at Rangpo Sikkim and above name persons are land Mafia of the locality and their intention is to extort money from us at any cost.

It is also need to mention here that they are very dangerous and desperate in nature and they have no respect to the law of land and at any time they may take law in their hand and I along with my family is leaving in fear of death at any time untowards incident may happen.

Therefore I with my folded hands request yourself to investigate the matter and Take a strong legal action against the above named persons and his associates.
