Sub: Formal Complaint Regarding Physical Assault and Attempt to Murder.

Respected Sir,

With reference to above, I am writing to formally report a distressing and life-threatening incident of physical assault that transpired on 17/03/2024, approximately around 11:00 am, at Subhas Pally Bazar (Rathkhola Bazar), in Ward No-22, Siliguri. I am a retired government employee, aged 68, residing at Rathkhola Bazar, and the victim of this appalling assault.

During my routine gardening activity on my plot (which is adjacent to my brother Gopal Mandal's residence), I was viciously attacked by him and his wife, Roma Mandal. The altercation commenced when Roma Mandal directed abhorrent verbal abuse towards my mother, who was present to pluck flowers from my garden. Upon my objection to her reprehensible behaviour, the situation rapidly escalated, with both Roma Mandal and Gopal Mandal resorting to derogatory remarks aimed at me and my family.

Subsequently, Roma Mandal deliberately drenched me with water ~~and~~ ~~but~~ thrown by a mug lime and again and hurled several bricks in my direction, attempting to hit my head which I narrowly evaded.

Their aggression persisted as they forcefully banged on my gate, compelling and provoking me to ~~scuffle~~ confront them. In the ensuing confrontation, Roma Mandal forcefully shoved me to the ground, resulting in injuries to my knees, elbow and back. While incapacitated on the ground, I was subjected to repeated blows from a bamboo stick wielded by Gopal Mandal and Roma Mandal, causing further harm to me.

Numerous witnesses observed this reprehensible act of violence, with some  
courageous individuals endeavouring to intervene. Following the cessation  
of the assault, I managed to seek refuge in my rented home at  
Rathkhola, whereupon my son promptly transported me to the  
Sikiguri Hospital for medical evaluation. The attending physician documented  
the injuries sustained and provided requisite medical treatment, as  
reflected in the enclosed medical report.

Their troubling behaviour is directly related to an unresolved land dispute  
between our families, which I previously brought to the attention of  
your department under GDE No 150, date 03/02/2024.

On multiple occasions, during my routine visits to my plot for gardening  
purpose, they have subjected me to verbal abuse, vile insults, and  
wishes for harm to befall me and my loved ones.

Furthermore, Roma Mandal and Gopal Mandal have resorted to outright  
threats, menacingly suggested that they possess the means and intent  
to fabricate false allegations against me and my sons and daughter,  
with the malicious intent of incarcerating us.

The assault under this application has not only inflicted physical harm but  
has also left me traumatized, robbing me of my dignity and  
insulting a persistent sense of apprehension.

I implore your esteemed department to undertake immediate and thorough  
investigation into this matter, apprehend the perpetrators, and ensure that they  
are held accountable to the fullest extent of the law.

I stand to cooperate fully with your investigation and provide any  
additional information or testimony deemed necessary.
