Sushanta Sarkar, of Durganagar, Ward no. 40, Sme, urge to state that, as a social worker and a ward-citizen, I was present at the fire accident zone of Durganagar today around 11.00 am. At that time, MLA of Dabgram-Fulbari, Smt. Sikha Chatterjee arrived at the spot with her team. As she is the people's representative, I approached to her to ask how she could help the fire-victims there. I could not finish my words that some of the goons who came with the MLA attacked me and some other residents physically with slang language and threatened me that they would kill me other day. Two among the goons I personally know. They are -

1. Anindita Biswas (Burai), S/o Lt. Sukumar Biswas, Add Ashrafnagar, W/NO-40, Sme
2. Dilip Roy, Add - North Ekliasal, W/NO-40, Sme

I shall, therefore, be thankful to you if you kindly lodge an F.I.R for this incident, and take necessary action against the goons as mentioned above as soon as possible.
